## Courthouse records

### Worcester Superior Court

#### Judge John S. McCann

**Johnny T. Stephens**, 28, of Manchester, N.H., was sentenced to three to four years in Walpole State Prison after pleading guilty to trafficking in cocaine. A charge of driving without a license was filed after a guilty plea. A charge of possession of cocaine with intent to distribute, amended from possession of cocaine with intent to distribute (second or subsequent offense) was dismissed at the request of the commonwealth.

**Alison Skerrett**, 18, of 53 May St., Worcester, was sentenced to two and a half years in the House of Correction, with one year to be served, after pleading guilty to assault and battery with a dangerous weapon (knife). The balance of the sentence was suspended for five years with probation. She was placed on probation for three years, to begin upon her release, after pleading guilty to armed assault with intent to murder (knife).
