The piece is actually a press release from **FEMA**..."No, not that FEMA, the other one across the pond"...the Federation of European Motorcyclists' Association.

October 8th, 2009 Driver distraction confirmed as first accident factor.

Three out of four vehicle crashes are caused by drivers being distracted, according to a study by Heriot-Watt University in the United Kingdom. Sending text messages at the wheel and dealing with children in the vehicle have been identified as the two biggest causes of accidents.

Results from the study conducted in the United Kingdom showed that despite the risk of being fined, among the respondents 52% admitted using a mobile phone while driving, and 40% said they had written text messages at the wheel. Other technological devices such as MP3 players and satellite navigation systems were found to cause lapses in concentration and attention leading to accidents.

FEMA has been campaigning vigorously to increase awareness training for all road users, in order to decrease the number of distraction-related accidents. Failure from car drivers to see an incoming motorcyclist remains the largest cause of car/motorcycle accidents.

WIND & FIRE COMPLETED RIDES & RALLY'S

Article on trip to Vierzon France on March 3, 2010

This March I had the pleasure of traveling to Europe and visiting Fred Fournet, the WFMC French Chapter Founder for a day. This visit came at the end of a ten day trip to London and Paris for sightseeing and pleasure.

We, I was traveling with my fiancé, and her sister. Now how many of you can say that you traveled to London and Paris

for ten days with two beautiful women. Yes, it was great. After a few days in London, seeing the British Museum and the Rosetta stone, and shopping at Harrod's, walking in Hyde Park and spending some time at the Charles Dickens Museum, we hopped on the Eurostar and took the three hour ride to Paris, under the English Channel. We had heard about the troubles the Eurostar has had, but we protected ourselves from any blackouts or stoppages because I took a flashlight.

We arrived at the Gare du Nord station and immediately took a cab to our hotel on the Rive Gauche. (Left Bank). During our visit in Paris we spent a lot of time in museums such as the Lourve, Musee De Orsay, Rodin Museum and garden, Sacre Coure, Montremarte, and Notre Dame. Paris is a great city, full of fun and activity. Luckily, I have been studying my French and we got along well with the locals. While in Paris, we did see plenty of Fire Dept activity buzzing around the streets.

On the 3rd of March, the date that Fred and I chose for the visit to Vierzon, I hopped on a train in the Gare Austerlitz. I arrived at the station 45 minutes early, and got in line for a ticket. When I got to the head of the line, it was the wrong line and I had to start over. 20 minutes gone, and no ticket yet. In the other line, there was an old lady who just could not get her money out of her purse, so I got in another line, 10 more minutes gone. The train was now leaving in 15 minutes and my line was moving, but slowly. When I go to the ticket man, he said I had 8 minutes to make the train, and processed my ticket, leaving me with just 4 minutes when I got it. I started jogging down to the train, and just stepped on it as the conductor blew his whistle, all aboard. Good thing I left myself 45 minutes to make it.

The ride down to Vierzon was a beautiful trip through the French countryside, in the early morning. I had never met Fred nor had I seen a picture of him. So, I was wondering how to find him in at the station which he said he would meet me at. When I arrived after the 1.5 hour trip, He was there on the platform with his Wind and Fire vest on, easily recognizable to anyone who knew what it was. We greeted each other in the traditional French way, and off we went to the fire station.

Vierzon is a quiet French town of 20,000, nestled in the rolling hills of central France at the confluence of the Cher and Yevre Rivers which feed into the River Loire. The Loire River Valley is a famous area for vineyards and has many chateaus dotting the countryside.

Fred drove me to the fire station which is in the center of town. They have only one station serving the community with 10 firefighters on duty at one time. They work a 56 hour week. Fred is what we would call a Battalion Chief for his shift, although they refer to him as a Captain. We toured the station which had at least 12 vehicles in it from ladder truck to ambulance, heavy rescue, brush truck, triple combination pampers and water rescue vehicles along with the usual cars and utility vehicles.

We took a look at the uniforms and helmets, which are cool, chrome, with built in visors and neck shields. All the equipment was clean and operational and efficiently placed on the respective vehicles. I met the on duty crew, and they were all great and cordial, although only one of them spoke any English at all. They have a great physical fitness program and workout area in the station, along with offices and a small museum of antique fire apparatus (push cart types).

Enclosed are pictures of the station and crew. Fred gave me a couple of tee shirts, patches and a satchel to carry them in. It proudly says, Sapeurs and Pompiers, Vierzon France, with a nice helmet logo. I also returned the favor by giving him a gift.

After this visit, we got in the car and went to Fred's house to check on his Yorkshire Terrier. We had a glass of French wine at the house, and I checked out his Harley. It is a nice blue full dresser, painted well, and has all the WFMC logos attached. Fred has had to leave it in the garage for the past few months because of the weather but he is looking forward to getting it out on the road. He is planning on riding to Nantes to meet up with other members in April.

After pictures at the house, we went to a pizza parlor, (I was hoping for snails for lunch), for the noon meal. It was a good lunch and we sat and talked about France, WWII and friends and family. I assured him that sometime he would be seeing more WFMC members dropping by his town, and encouraged him to come to America. He is thinking about coming to next summer's run from Arkansas to South Dakota.

Fred is married to Marie-France, his wife of 20 years. She works for social services for the local government and was unable to meet with us during my visit.

After lunch, we walked the pasta off with a tour of the town. Vierzon is an old Medieval town, complete with a central walled city which is now a sort of castle. We saw the Notre Dame du Vierzon church and paid homage to the soldiers lost in WWI and WWII, who are commemorated in the church. We walked over the river Cher to the south side of town and came upon the demarcation line used in WWII which separated the unoccupied zone of the south of France from the northern part, which the Nazi's occupied. Fred told me about the problems that townspeople had during the war, with the Nazi's. People used to try to escape Nazi persecution by swimming the Cher River while the guards would just take pot shots at them in the water. Turns out that Fred is a history buff, just like me.

As we were walking back to the car, we passed a tattoo shop which Fred owns. I met the artists and a customer getting some work done on him. Then we went to the local Golds Gym and met the former French middleweight boxing champion, who happens to be a good friend of Fred. Actually, everyone in town is a friend of his, since he is a fireman and great guy.

As we were driving back to the train at 3pm, we stopped by a pub and had a final toast to our friendship and visit. It was a



great day and I am hoping to see him again either here in the US or over there if possible.

When I got back to Paris, it was evening and I decided to walk back to the hotel, a mere mile from the Gare Austerlitz. Wrong, I got lost and it took me two hours to walk the one mile. You might say, I took a round trip. Anyway, when I got to dinner with my fiancé and her sister, I had a bit of Escargot to celebrate my visit. The rest of dinner was satisfying and the total visit was great.







A Couple of Days Riding: Monday, the day after Daylight Savings, I took off on a Bakersfield / Ca Hwy 58 loop. I mentioned this putt a couple of weeks earlier but grabbed no takers. Anyway, the date seemed like a good day for a ride with forecasted temps in the 70's. My plan was to catch sight of the spring posies blooming along that meandering, country two-lane, Hwy 58. Bakersfield is about 150 miles from Santa Barbara. I made it there to my favorite breakfast spot, the 24th

Street Café, at 11:30. The food was great – Chili Verde scramble, hash browns, biscuits & gravy plus coffee – all for about a third less cost than in SB. After grub my ride on Hwy 58 proved mostly green with occasional golden flowered hills. The color spectrum exploded when I got to California Valley. The green was splattered with blue, light blue, yellow, light yellow, orange (California poppy), purple and violet. My pick of the day was the sparsely appearing small light-blue flowers with whitish centers.

The route drifted through cattle ranches with an occasional dotting of stock on either side of the road. On one straight stretch a young black cow, almost full grown, was wandering dead ahead in my path. I slowed my Wide Glide to a crawl; but, even though my pipes are pretty mellow, I still spooked the cow enough to have it hurry to the shoulder and scamper a ways along the fence line. I figured a rancher needed to be told. Two miles up the road I pulled into a homestead festooned with pickup trucks, a tattered windowed ranch house, a weathered barn, one tractor, out buildings, paved & dirt drives and a welcome sign nailed to the front gate "Private Property – No Trespassing!" I putted around the ranch yard looking to hook up with someone. No one came out. I rode further up the dirt to a second house deeper in flanked by a more pickup trucks. Still no one showed!

Having given up the search I was in mid retreat when a fellow cold beer in hand, dressed like a typical slim cowpoke, approached me followed by his wife a few steps behind.

"One of your cows is out on the road about two miles back", I said.

Poke, "Is it about this tall (indicating waste height)?" "Naw, it's about this tall (I indicated about a foot taller)."

"Must be one of my neighbor's. I'll go get it."

Thank you, sir."

"Take it easy."

Eventually I made it to Hwy 101, took a break in San Luis Obispo and then rode back home -375 miles and a very nice ride.

Wednesday, the third day after Daylight Savings, I went riding again. This day's 270 mile trip was to Cambria, a small coast town located midway between Santa Barbara and Monterey. The ocean route there, along Hwy 1 north of Morro Bay, offered a shoreline view of blue water with white capped waves rimmed by wind blown mist plumes. 
