TERMS AND CONDITIONS

PLEASE READ THE FOLLOWING INFORMATION CAREFULLY BEFORE SIGNING THE APPLICATION TO OVERCOME ANY POSSIBLE MISUNDERSTANDINGS OF THE DAY ATTENDING THE CRAFT FAIR!

1. *I understand that I will be responsible for any loss, theft or damage of my own products.*
2. *We will work together as a team and help to make it a pleasant atmosphere.*
3. *If there are any problems, I will contact the organiser and, to overcome misunderstandings, try to fix the issue.*
4. *I understand that the deposit is non returnable except in special circumstances.*
5. *I understand that I will not be able to take heavy goods/machinery unless by prior arrangement.*
6. *I understand that additional space for extra display equipment is solely at the discretion of the organiser at the event and prior arrangement cannot always be guaranteed.*
7. *Applications for stand space can be made by completing the registration form attached. The organizer reserves the right to grant, or refuse, any application without giving reasons. An application for stand space indicates the applicants' acceptance of these terms and conditions. The only terms and conditions that will be applicable to the contract will be those of the organizer.*
8. *Some events may require additional forms and insurances for the legal purposes of the landowner.*
9. *I understand that if I display goods not considered suitable for the event I may be asked to remove them and agree to do so. This does not affect the stall booking fee which must be paid..*
10. *The stand space must be cleared completely within one hour of the fair closing.*
11. *All exhibitors should arrive in sufficient time to allow them to fully furnish their stand before the fair starts.*
9. *I understand that it is my responsibility to have adequate insurance to cover my activities.*
10. *The Exhibitor is obliged to return after the end of the exhibition the exhibition space, stand and inventory they were obligated with in the same condition they received them, and in case of damage, they are liable to compensate for it.*
