To be accepted for local school exemption, my gross income, from all sources, together with the gross income from all sources of my spouse and all members of the family residing within the homestead, for the immediately preceding year, did not exceed \$20,000. And that no transaction has been made in collusion with another for the purpose of obtaining this tax exemption contrary to law.
