

Used and Refurbished Systems **Limited 30 Day Warranty**

J's PC Repair hereby warrants this product to be free from defect in the normal operation of the software environment, under normal use and conditions, for a period of 30 days from the date of purchase.

Should this product fail to function in the manner for which it is intended, J's PC Repair will repair this product without charge (notwithstanding a \$10.00 handling and insurance fee). This decision is subject to verification of the defect or malfunction upon delivery of this product to J's PC Repair.

Before returning this product for service, please call the number listed below for technical support.

If service is still required:

1. Remove all electrical connecting cords and external equipment;
2. If possible, transport the product in a padded environment (e.g., box lined with blankets or other packing material).
3. If the product is still within the warrantee period, bring proof of purchase with the product to be serviced. Proof of purchase must include the date the product was purchased.
