**Vendor Information**

- All vendors must complete the vendor application (enclosed) and submit it **via email** no later than three days after receipt of this information packet. We need a list of whom we will be expecting. I do not expect to turn any vendor away unless they do not meet the requirements etc listed below.
  - In order to show your commitment, we ask for a **\$5.00 commitment fee**, which will be returned at the end of the program. This should be submitted by mail and written out to (check): Children’s Miracle Network.
- All items for sale must be age-appropriate for children. No questionable items are permitted.
- There is **no table fee**. Instead you are asked to give a percentage of your day’s sale proceeds directly to Children’s Miracle Network. Turn around time must be no later than a week for the proceeds to be submitted back to Victory Mohamed, Miss Urbana 2010
  - We ask that no less than 20% be contributed to CMN.
  - A sign will be posted with your agreed percentage at your table so our audience knows just how much their purchase will mean for CMN.
- You are asked to arrive and **check-in no later than 1:30pm** to begin your setup. Tables will be available on a first come-first serve basis. Tables will be arranged around the back of the event venue for viewing.
- You will sell during the “Mini-Fair” period of time (2:00-2:30pm) and during intermission. I highly suggest that you staff your table during the show (or have someone there for possible sales) and for at least 20 minutes after the show ends around 4:00pm.
- You will need to sign a **“Partnership Agreement”** once we agree upon the terms. A blank copy of the agreement is included in this paperwork for you to view. After we agree on the terms (and your application has been submitted), I will complete the agreement and mail it to you. You are asked to review it, sign it, and send it back within one week of your receipt, so I know exactly whom I can expect. All partnership agreements are due back to Victory Mohamed **by Saturday, May 29<sup>th</sup>**.
- All vendors are also asked to **provide a “silent auction” item**.
  - This can include an item and gift certificate or a few items. Be creative! Please include your item in a basket, if possible.
- In return for free table to display your services and the extensive advertisement, all vendors are *asked* to place a **small ad in the Miss Maryland Program book**. The information is included in this packet. This can be a logo or ad you have prepared. This must be submitted as soon as possible – **deadline Wednesday, May 26<sup>th</sup>**.
  - This is a very quick turn around time. While all the event proceeds are benefiting CMN, we are also contestants of the Miss Maryland program and would sincerely appreciate your help by providing a

small ad. This will be statewide advertisement for your goods/services. Please do consider placing a larger ad if you see fit, in return for our event efforts.

**What you will receive in return:**
