# NYCKEL CITY MUSIC FESTIVAL

### I. REGISTRANT'S RESPONSIBILITES

- 1. Registrants must send Registration Package with these required materials: Registration Form completed in its entirety, a non-refundable money order for \$40 processing fee (cash may not be sent to us by mail or otherwise), the Registrant's CD of original and Copyrighted music, bio and photo. Musicians must send their own original music if genre is Hip-Hop/Rap. In the Case of Cover Songs: Applicants are permitted to submit their rendition of a cover song as long as the song has been rendered in an original format/style.
- 2. All Registrants that make music within the selected genres will be considered in the judging process. This competition segment of the Music Festival will allow the winners to perform for A&Rs that represent their respective companies. Also, winners will be presented with an award commemorating their accomplishment and other prizes to be mentioned later. THE ONLY MUSIC GENRES THAT WILL BE CONSIDERED FOR JUDGING ARE (and sub-genres of each general category): ROCK, HIP HOP/R&B, REGGAE, JAZZ/BLUES & COUNTRY. For instance, "Alternative Rock" will be considered under "Rock".
- 3. NYCKEL CITY MUSIC FEST & NYCKEL CITY, LLC is not a distribution, production company, or demo shopping service and is not contractually affiliated with any companies involved in the music industry through any partnerships or agreements whatsoever. NYCKEL CITY MUSIC FEST & NYCKEL CITY, LLC does not guarantee any exclusive, non-exclusive, or independent recording contracts.
- 4. NYCKEL CITY MUSIC FEST does not accept musicians that are contractually obligated to a major recording company or any production companies with agreements to produce music which will be promoted and distributed by a major record company.
