A presentation of historical analysis of real estate values involved and options on how to resolve the issues will be discussed.

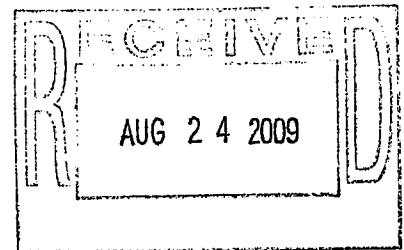
