



IMPORTANT NOTES FOR AUTHORS:

ARCHIVING POLICY

Self-archiving

Authors whose articles have been published in JGBI retain substantial rights, such as self-archiving:

Authors are allowed to self-archive their JGBI-accepted article manuscript on their own websites. Authors may also post this version of their manuscript in any repository, yet, they will only do so 12 months or more after the official JGBI publication. However, authors are not allowed to use JGBI's formatted version (the final article), which is made available through several global databases. In posting the author's version of the manuscript to other resources, acknowledgement should be given to JGBI, along with a link to JGBI's website.

Archiving Policy in case the journal would no longer be published

JGBI's content is available through EBSCO and ProQuest's ABI-Inform databases. The formatted and published article can always be retrieved via these resources. Additionally, content of all JGBI issues is available through the editor, who is a co-founder of the journal.

ARTICLE WITHDRAWAL, RETRACTION, AND CORRECTION INFORMATION

It is customary in scholarly publications that the editor of a scholarly journal is exclusively and autonomously responsible in making the decision as to which articles submitted to the journal shall be published. The editor's decision is guided, however, by the policies of the journal's editorial board, as well as the commonly accepted legal requirements such as libel, plagiarism, and copyright infringement. This principle serves to safeguard the essence of the scholarly archive as a permanent, historic record of scholarship transaction. Published JGBI articles shall remain in existence, in exact and unchanged format, for as far as is possible. Yet, there may be extremely rare circumstances in which an article is published that we must later retract or remove. JGBI does not consider or engage in such practices lightly. There will have to be compelling, exceptional circumstances in order to do this. In all cases, our JGBI archives, supervised and maintained by the editorial board, will retain all article versions, including retracted or otherwise removed articles.

Article Withdrawal

This pertains to articles in production process ("press"), that may contain errors, have been submitted twice, or infringe on professional ethical codes, such as submissions to multiple journals, false authorship claims, plagiarism, data fraud, and so on. An article that is in Press (accepted for publication but not yet formally published) and includes errors, or turns out to be an accidental duplicate of another published article, or is found to potentially violate JGBI's publishing ethics guidelines in the editor's view, may be "Withdrawn" from JGBI. This means that



the article content will be removed and replaced with a statement that the article has been withdrawn according to JGBI's policy on withdrawals for articles in press.

Article Retraction/Correction

This occurs in cases of violations of scholarly journals' general ethical codes, such as simultaneous submission of the same article to multiple journals, false authorship claims, plagiarism, data fraud, and so on. In very rare cases JGBI may also use retraction by way of correcting errors in submission or publication. Editor or author article retraction per advice of the scholarly community is an occasional, yet established feature of the scholarly world. In such cases a retraction note, titled "Retraction: [article title]", and signed by the authors and/or the editor, will be published in a subsequent issue of JGBI.

Article Removal: Legal limitations

It is very rare, but it may happen in specific cases, that JGBI has to remove an article from the online databases. We will only do so when an article is derogatory or infringes the legal rights of other individuals or groups. It may also happen when an article turns out to be the subject of a court order, or might pose a serious health risk. The nature of JGBI articles is not of a kind where this will happen too often, yet, as a matter of precaution, we considered it prudent to include this policy here. In these circumstances the metadata (Title and Authors) will be retained, but the article text will be replaced with a note indicating that the article has been removed for lawful reasons.

MALPRACTICE AND PLAGIARISM

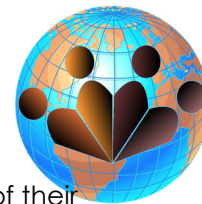
JGBI is committed to publishing original scholarly materials of the highest quality that provide comprehensive insight into all aspects of business performance, locally, regionally, and internationally, and business science. It is JGBI's aim to facilitate the availability of academic excellence and circulate insightful and innovative knowledge worldwide.

JGBI's editorial team and authors are provided written guidelines and checklists that must be followed to maintain the high value that JGBI places on the work it publishes. JGBI reviewers are a critical component of the scholarly process. Hence, they are instructed to provide comprehensive, detailed assessments of work that they are reviewing to assist the author in improving the quality and usability of the presented research.

JGBI emphasizes that ethical publication practices are critical to successful knowledge development. JGBI therefore maintains high ethical standards in its journal.

Plagiarism

JGBI defines plagiarism as intended or unintended use of other individuals' or groups' ideas, theories, models, equations, conclusions, research (intellectual property), and/or verbatim or paraphrased words *without proper attribution to the original source*. Plagiarism is considered to be an utterly serious breach in publication ethics. Therefore, any allegation of plagiarism will be meticulously scrutinized. We also closely review all submitted manuscripts to assess whether plagiarism is involved and, if such is the case, to what extent. If a manuscript is determined to



contain plagiarism, JGBI's editor will immediately notify the author(s) of the rejection of their submitted work. This author or authors team may be barred from consideration for future publication with JGBI for an allotted period or indefinitely, at the editor's discretion. Further action may be taken as deemed necessary by JGBI's editorial board based on the severity and quantity of the plagiarism.

Claims of plagiarism, involving prior publication of an article in JGBI, will be inspected right after a complaint is received. Work that has been found to contain plagiarism will be removed from all databases in which JGBI contents are published. A statement of notification and retraction (see above) will be included at the electronic database link providing the citation for the original work. The authors of the work that contains the plagiarism will be notified of the findings, and any work currently under review will be returned. Authors of work containing plagiarism will be prohibited from publishing with JGBI for an allotted period or indefinitely, at the editor's discretion. Submissions accepted for review after the allotted period may be subject to extensive review by JGBI to confirm that no plagiarism is included. Further action may be taken as deemed necessary by JGBI's editorial board based on the severity and quantity of the plagiarism.

Simultaneous Submission

Simultaneous submission is defined as work that has been submitted to JGBI for publication, but that is also under review, has been published, or has been accepted for publication elsewhere, either partly or in its entirety. While JGBI acknowledges the importance of the use of previously published work to evolving research, we also feel that work submitted for publication must demonstrate sufficient progress in the research conducted and should appropriately cite and attribute the earlier work for any prior research mentioned. Failure to disclose previously published work upon which the current work is based may be considered cause for investigation into claims of plagiarism.

COPYRIGHT POLICY

Articles submitted to JGBI should not have been published before in their current or a substantially similar form, and should not be under consideration for publication with another journal. Authors submitting articles for publication guarantee that their work is not a violation of any existing copyright and will indemnify JGBI against any breach of such warranty. For ease of dissemination and to ensure proper policing of use, papers and contributions, in their final format, become the legal copyright of JGBI unless otherwise agreed.

Third party copyright permissions

Before an article is submitted to JGBI, the author(s) should obtain any necessary permission for the use of content that is not their own creation. Failure to do so may lead to extensive postponements of publication. JGBI requires:

- Non-exclusive rights for reproduction of the article.
- Print and electronic rights.
- Worldwide English language rights.



- When reproducing tables, figures or excerpts (of more than 250 words) from another source, the following is expected from authors:
 - They will obtain advance written permission from the copyright owners for the use of any of their text, illustrations, graphics, or other material, in their manuscript.
 - If authors substantially alter copyrighted material, they must inform the copyright holder(s) of the original work.
 - Authors must always include the source in figure captions as well as in the reference list.
 - Authors should not assume that any content available on the web is free to use. Please check the website for details of the copyright holder to seek permission for re-use.
