CYNTHIA HICKS

My lawyer and my husband, Dell Hicks. Dell helped me sue the circus for...

DELL HICKS

... loss of income, alienation of affection, breaking a verbal agreement, civil rights abuses, animal abuses, improper hiring, unfair recompensation, mental anguish, emotional distress.

BOOTH

Have any of these gone to court?

DELL HICKS

It's just a matter of time, Agent Booth.

BOOTH

You really hate that circus.

BOOTH

Where did you leave things?

DR. ALBERT MUIR

In the end it didn't matter what any of the rest of us thought. Julie and Jenny were going to have to come to an agreement.

BRENNAN
