#### 4. Guest Speakers and Public Discussions.

**4.a. Mike Ellis, Land and Resource Planner, EM&R.** Ellis gave an update on the Land Use Planning process. First Nation engagement is expected over the summer of 2022. In the late fall / winter there will be plan revisions, There is new growth in population, the demographics and zoning along with other issues to be discussed. By winter Ellis expects to have a revised draft of the plan for public presentation, after which there will be further plan revisions. In 2023 the plan will go for approval process by three governments, with a possible fall implementation.

Council thanked Ellis for his presentation and agreed to have him talk to Council again in a few months.

#### 5. Report From the Chair & Correspondence.

Council received an email from Community Services as to whether the community would like sand bagging stations this summer. It was agreed that it would be proactive to have one at Army Beach and one at the community centre for this summer. The majority of property owners have left their sandbags in place over the winter and could require some repairs before the water rises. Currently the water level is similar to 2007 flood levels.
