ELECTION INFORMATION

The annual Homeowners Directors Election will be January 12, 2010. Three directors will be elected for a three-year term. The following information applies: **Thursday, December 10, by 6:00PM**, petitions for Candidates by Petition to AWHA Secretary

Tuesday, December 15, 7:00PM, Apache Wells Church social hall: Meet the Candidates

Wednesday, December 16, 9AM-3PM, ballots will be available to be picked up and signing the register by persons of record, and providing valid photo ID, from the Election Committee in the Homeowners Office. The remaining ballots will be mailed to residents of record. In order to be valid and counted, the absentee ballot MUST be signed and returned in the envelope provided and MUST be received by return mail no later than Tuesday, January 12, 2010, 2:30PM or it may be delivered to the guarded double locked ballot box in the Homeowners Office **January 4-8 and 11-12, 2010, 9AM-3PM**.

A provisional ballot will be given to the voter if 1) you have misplaced your absentee ballot or you did not receive an absentee ballot, by providing a valid photo ID and signing the register; 2) if the voter is unable or unwilling to provide a valid photo ID; 3) if the voter's name is not on the register as an eligible voter, e.g. Power of Attorney, Estate Trustee, or property has closed escrow; 4) if the register shows an absentee ballot has already been received. **Only one vote per residential unit is allowed.** If you have any questions, please call Carolyn Agee at 218-1137, Election Chairperson.
