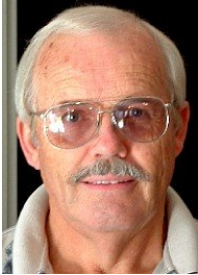

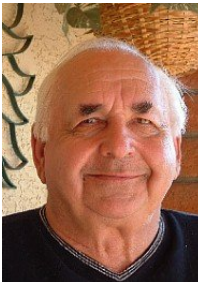

Homeowners of Apache Wells.....

- are spending \$723,000 of our money on the purchase of the Cancer Fund building without our vote.
- have developed a proposal for an \$8,500,000 Community Center that would require a \$6,000 assessment to each homeowner.
- have supported a \$950 transfer fee with \$100 of each fee going to the AWCC.
- have unnecessarily increased the monthly homeowners' dues.
- are circumventing the current CC&Rs, Architectural Rules, and Bylaws.
