

NOTICE OF INTENTION TO CIRCULATE RECALL PETITION

TO THE HONORABLE John McCann:

Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of Chula Vista in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of City Councilman, in Chula Vista, California, and to demand election of a successor in that office: The grounds for the recall are as follows:

Inefficient/Ineffective Leadership: Bungled termination of the City Manager; agrees with almost everyone, but follows through rarely; often overly influenced by the opinion of mayor; willing to ignore General Plan policies and ordinances for favored developers.







Fiscal Irresponsibility: has approved excessive use of consultants and no bid contracts; allows developers to benefit at expense of existing residents & businesses; voted for spending reserves to meet operating expenses.

Poor Interface with the Community: improper use of closed sessions; lack of concern for the health and safety of all community members.

Environmental Mismanagement: voted to weaken city's environmental policies; refusal to oppose placement of peaker power plant within 350 feet of homes and near schools.

Violating Conventional Standards of Fair Play: has berated fellow council member in public from dais; goes along with preferential treatment for out of town developers.

A copy of this notice and proof of service will be filed with the City Clerk. Elections Code section 11023.

(a) Within seven days after the filing of the notice of intention, the officer sought to be recalled may file with the elections official, an answer, in not more than 200 words, to the statement of the proponents.

(b) If an answer is filed, the officer shall, within seven days after the filing of the notice of intention, also serve a copy of it, by personal delivery or by certified mail, on one of the proponents named in the notice of intention.

(c) The answer shall be signed and shall be accompanied by the printed name and business or residence address of the officer sought to be recalled.
