Did you perform a conventional upgrade or a clean install? Did you go with a dual boot configuration?


Before you upgraded, did you run Microsoft's XP Upgrade Advisor or any other compatibility test? What did it find?

Did you stick with Windows XP? Would you upgrade again?









NACC MESSAGE BOARD!!

You just installed Windows XP. You remembered to register with Microsoft, to avoid crashing when your trial period runs out.

That "free" media player software that is real convenient, because you don't need a separate program for each format or manufacturer, may not be to your liking. Without your permission, it will be logging each song or movie you run or software program you install, in a file similar to cookies.

The event will be recorded and you will be branded a thief of copyrighted material. That CD was not assigned to your computer, it was assigned to your friend's. Microsoft will know that and you will be charged..

You can change the engine in your car without notifying the manufacturer, but you can't change a program on your computer.

They now have assigned a number to your computer and what goes on it. Don't try to change too much or add something without advising Microsoft. Father is watching.


Suppose you have a small, but valuable, collection of skin flicks on DVD. You may not want to give your wife your password, or your little game could be revealed.

SUCCOS Are Coming by Bill Pryor



Toshiba has developed a new rewritable optical disc with a capacity of 30GB per-layer, per-side, and a companion read/write optical head that incorporates a blue laser. The new optical disc, which measures 12 centimeters in diameter, has a capacity of more than six times that of similar-sized DVD media, which have a single-sided capacity of 4.7GB. The new disc allows for recording 3 hours of high-definition digital video, a Toshiba statement says.

Those of you who have attended my Internet Meetings have encountered my presentation of wave theory and how it applies to science and computing. The current CD lasers being used are red. The secret in developing these higher capacity CDs lie in the ability of the new solid state blue lasers to produce a shorter wavelength than the current red lasers being sold today on new PCs.

Blue lasers have a wavelength of 405 nanometers, shorter than that of red lasers, which have a wavelength of around 650 nanometers and are used for reading and writing DVD and CD discs. The shorter wavelength means the laser can register smaller dots on a disc and more data can be stored. As a result, blue laser technology has been adopted for the development of next-generation optical discs.

Developers have been working to create a blue laser for CD applications for over 25 years; they have realized the shorter wavelength of the blue laser will result in higher capacity storage CDs. I feel it is important to include and teach some basic physics and wave theory when using computers to familiarize users as to what is going on underneath the hood.





Boycott Microsoft!

icrosoft's XP software violates the law and abrogates consumer rights.

When you buy XP software, you do not own it, instead Microsoft owns you.

can remember when Microsoft was just another software company, subject to market forces and amenable to common sense. I can also remember when A.T.&T. was a telephone company.

But that is all in the past. At the time I write this, Microsoft is in the process of releasing Windows/Office XP, and this release signals a historical departure for Microsoft. It signals the first shot in a war — a war between Microsoft and its customers.

Read the following dialog carefully, and welcome to Microsoft's "Brave New World."

Under this new system, your obligation to Microsoft doesn't end when you purchase the software, that merely begins it. Not included in the activation dialog is the information that trivial system changes may invalidate your activation, you will be required to contact Microsoft each and every time you need to re-activate the software for whatever reason, or if you try to sell or give away the software (Microsoft only allows this to happen once), or if you try to exercise your right to install the software on two systems used by one person. Also, the total number of activations is always less than 12, after which you must throw the software away and start over.

The XP series (Windows and Office) has a new feature — "product activation" — that perverts the relationship that normally exists between seller and buyer — when you purchase an XP product, you don't own it, instead Microsoft owns you.

The feature works like this:

You buy a copy of (say) Office XP.

When you install it, the installation program requires you to contact Microsoft, otherwise the program goes into "trial mode," a 50-day period after which the program is disabled. You must contact Microsoft to keep the program from shutting down.

On being contacted, Microsoft "authorizes" the installation. It also asks you for a lot of personal information, some of which is optional —

but only the first time. Read on.

If you have to re-install Windows or the software because of a virus, a hardware failure or some other cause, you have to contact Microsoft again and explain why you need their permission to re-install the software. If they don't like your explanation, and in particular if they do not get your name, address, phone number, and E-mail address, you are out of luck — you must buy another copy of Office XP1.

If you need to make a copy of the software on another computer for a legitimate reason (say you own a desktop and a portable, but you never use them both at the same time), you are out of luck — you cannot do this. Microsoft will assume you are a criminal and refuse permission 1.

If you decide to move your copy of XP permanently to another machine, Microsoft will not permit this, instead they will assume you are a criminal and refuse permission1.

If you decide to de-install and sell your copy of XP to a third party, Microsoft will not permit the new buyer to install the software, instead they will assume he is a criminal and refuse permission1.

If, on the other hand, you jump through all Microsoft's circus hoops, it seems you are limited to eight re-installations (some say eleven), after which you might as well throw away your expensive software. This means if your system is attacked by viruses, if your hard drive fails, or if you regularly upgrade your hardware and try to transfer your programs,

you are going to be buying a lot of extra, expensive copies of Microsofl XP.

In short, you can either (a) accept the default single installation (the only relatively painless one — but which requires you to contact Microsoft) and then throw the software away, along with any data files you have created that rely on the software, or you can (b) become a

In short, you can either (a) accept the default single installation (the only relatively painless one — but which requires you to contact Microsoft) and then throw the software away, along with any data files you have created that rely on the software, or you can (b) become a Microsoft's a vassal, a petitioner, entirely dependent on Microsoft's conception of fair play.

And, no matter how your petition turns out, there is one thing you need to realize — Microsoft decides. You are no longer a citizen in a democracy, a responsible moral agent — Microsoft decides whether you are a criminal or not, and they decide this in advance.

Back when the American Constitution was the law of the land, a plaintiff had to wait until a crime was committed, then go before a duly appointed judge and appeal for justice. Microsoft has circumvented these democratic inconveniences and has become a law unto itself.

And make no mistake about it — Microsoft is breaking the law with the XP series, in many ways. Consumers have legitimate, lawful reasons to re-install software, reasons to install the software on two machines used by one person, reasons to re-install after a system failure, reasons to un-install and sell a computer program. But under the Fascist XP system, the consumer loses all these rights.

I would list all the laws Microsoft is breaking with the XP series, but that would require more space than your computer has memory. Here are some highlights:

Presumption of guilt. Under American law, a person is assumed to be innocent until proven guilty. The XP system assumes a criminal intent, which is a violation of constitutional law, and then the software acts on this assumption, a power normally reserved to the police, which is an additional violation of law.

Prior restraint. This idea, basically acting to prevent a crime before it is committed, is a very delicate issue in constitutional law, and because of the potential for abuse, it is rarely permitted. Absent evidence of probable cause, it is never permitted. Because there are legitimate reasons to do things not permitted by the XP software, Microsoft is engaging in prior restraint, and is thus breaking the law. Misrepresentation. In commerce, there are a set of assumptions about an item that is offered for sale. To put it simply, a consumer item is assumed to be suitable for its stated purpose, and this is implicit — offering the item for sale creates some assumptions that, if they turn out not to be true, are actionable. The XP software series very simply

is not what it seems to be — a set of computer programs meant to serve the consumer's needs. This is false — XP only serves Microsoft's needs.

Surveillance. By setting itself up as a moral judge of how people use their software, by micro-managing how people choose to use the XP programs, Microsoft has put into place the most insidious system of spying ever conceived in modern times. Once a consumer has experienced any version of modern-day reality — a virus that requires the software to be re-installed, one person with two computers, or who buys a new computer, or who wants to sell or donate the XP software to a third party — however these events turn out, Microsoft gets every detail, along with all your personal information. If XP comes to full flower, Microsoft will know more about you than the US Government knows or ever imagined knowing.

That is the real reason for XP — it is not about preventing theft, it is theft — Microsoft, while preventing you from exercising your consumer rights, is also stealing information from you that you would never voluntarily give up. It is a desperate ploy to gather an incredible gold mine of information about you — your choices, your experiences, your name and address. And get this — you're paying them to do this to you.

Because of XP, very soon Microsoft will know so much about so many people (read: you) that they will no longer have to sell software — they can simply sell their consumer database. But this will only happen if you act like sheep and buy the XP series software. The choice, the power, is yours.

With the XP software, Microsoft shows that it holds you and your rights in contempt. Please — don't live up to their expectations.

That is why I ask you to:

Write your congressional representatives and demand that Microsoft be stopped.

Refuse to purchase any of the XP series of Microsoft software.



The other day I was watching FOX NEWS, when they started to talk about Olympic security. On my screen came a map of the whole United States, to all four borders. Quickly, with a continuous zoom, they were down to the main Utah Olympic complex IN GREAT DETAIL.

From the whole US to a small section of Utah in one zoom is quite an undertaking. You could see cars parked and what appeared to be groups of people. I think they could have read the license plates on the cars if they wanted to.

So much for a military platform in outer space with high resolution capabilities. Anyone want a portrait of their tank or weapons carrier in very high resolution>

They are spending our money, so they can afford the latest and the best. Showoffs!!

Commercial digital cameras haven't gotten that good yet. However, they have gotten good enough to give you a very sharp 8 X 10 with almost no effort. Even the low priced (entry level) cameras perform well with a 5 X 7 max print size.

Now, if you intend to project your images or put them on the Internet, a camera with a 640 X 480 image is more than adequate. You can get that with the cheapest camera. A 640 X 480 image is only 307,200 pixels and at 72 dots per inch is an 8.88 inch X 6.666 inch image, not sharp enough for printing but OK for the Internet. Over your head? See below.

So there is little financial limitation to getting into digital photography, just time and the inclination to produce a masterpiece.

You'll want a 3X zoom so that you can handle moderate wide angle shots and also take passable portraits, 38 mm to 105 mm is about right. I'm using the 35 mm equivalents since most people know them better than the much shorterfocal lengths of digital cameras.

As you grow in your hobby, you may want more control over exposure. Most digitals are completely automatic, with a plus 3 stop, minus 3 stop adjustment done electronically. However the high end "Prosumer" cameras have f stop and shutter speed adjustments that permit you to violate the rules of exposure for special effects.

"Prosumer" is a coined word invented to identify the more expensive digital cameras that cross over from amateur to professional use. Some even have extension flash receptacles that permit you to use a flash off the camera to avoid the very flat lighting you normally get with on camera flash.

If some of the words used here confuse you and you can't find them in a standard dictionary, have heart, see below.

Social Security

Perhaps we were asking the wrong questions in this past election year.


If enough people receive this message maybe a seed will be planted, and maybe good changes will evolve.



Netscape browser leaves cookies vulnerable

(eBCA) A security flaw in Netscape's Navigator Web browser can allow Web site operators view the information stored in cookies on a user's computer, InfoWorld reports.

The vulnerability affects Navigator versions 6 through 6.2, as well as version 0.9.6 and earlier versions of the open-source version of Navigator, Mozilla, according to an analysis written by Marc Slemko, who discovered the bug. The bug, Slemko said in his analysis, can be exploited by causing users to visit a Web address inserted into HTML code on a Web page or in an HTML-formatted e-mail. If the user were to view the malicious Web site, cookies could be stolen off the user's computer, Slemko said.

Cookies are small data files used by many Web sites to track user visits, preferences and identity. If a cookie is readable, it can be used to impersonate the rightful owner of that cookie on a Web site.
