

## DECLARATION OF LOKELANI LINDSEY

I, LOKELANI LINDSEY, pro se ("Lokelani") with assistance of the counsel named above, and now declare under penalty of perjury that I request the recusal of Judge David A. Ezra in this case of U.S. versus Lokelani Lindsey, filed in the U.S. District Court for the District of Nevada, CR. S-01-318 and CR. S-00-00482.

Lokelani never committed any money laundering and Lokelani never had any knowledge of bankruptcy fraud by Marlene Lindsey until the day she was indicted. Lokelani intends to move to reopen the bankruptcy case of Marlene Lindsey due to being defrauded by her and persons assisting her. There is no tangible or credible evidence that Lokelani knew about any bankruptcy fraud by Marlene Lindsey. Lokelani plea bargained in this case merely for the sake of her very ill husband and extreme intimidation, deception, threats, and false promises. Lokelani is innocent, and was merely targeted for political and related reasons.

Shortly after submitting Lokelani's July 30, 2003 Affidavit of Lokelani Lindsey to the Internal Revenue Service, Lokelani's automobile brake line was cut, Lokelani's transmission tampered with and a number of death threats were received by Lokelani on the telephone, including the threat that that Loke must, "Back off whistleblowing or you and Steve will be barbecued." A police report on this attempt to kill Lokelani was filed.

Internal Revenue Service Examination Revenue Officer Rebecca Mckenzie-Young recently prosecuted an assessment in violation of the exclusive jurisdiction of the Criminal Investigation Division regarding Lokelani's tax returns and recently amended tax returns, and in order to aid and abet in the further tampering with the Hawaii federal grand juries who must still see Lokelani's tax returns and felony admissions/confessions. Lokelani intends to seek a class

action suit by native Hawaiians against the Hawaii federal grand juries in order to enforce the native Hawaiians being arrested along with Lokelani for joining the corruption and coverup that has and is targeting Lokelani and many native Hawaiians.

Exhibit "1" of the Declaration of Lokelani Lindsey attached to this memorandum is a true and accurate copy of the Joinder to "Supplement to Joinder of Nolan Crabbe And Additional Petitioners to the Petition for Justice", and Received October 22, 1997 Herein, Exhibit "A"; Verification, received November 21, 1997 in Gabriel Aio, et al. V. William Chee, et al., U.S. Grand Juries for the District of Hawaii. The related case was a suit against the Hawaii federal grand juries to enforce their receipt of the Petition for Justice, which the Honorable Samuel P. King severed from its original case on January 15, 1998. Lokelani hereby joinders that Petition of Justice, even though the Hawaii federal grand juries never received the Petition for Justice or the suit to enforce its delivery to the Hawaii federal grand juries.

This document was joindered on December 10, 1997 by two of the royalty of the Kingdom of Hawaii, King Akahi Nui and Queen Akahi Wahine. Others have also joindered, including a key member of the reinstated Kingdom of Hawaii.

These documents and the documents they joindered contain legitimate felony confessions and evidence which were and still are being blocked from being investigated by the Hawaii federal grand juries, which are inescapably the responsibility of the Chief Judge of the federal court in Hawaii, which is and has been for years the Honorable David A. Ezra. Judge Ezra is therefore guilty of felony tampering with federal grand juries.

That Petition of Justice, its various joinders, and the felony confessions and evidence obviously were blocked from being received by the Hawaii federal Grand Juries.

Judge Ezra only enforced alleged crimes that Lokelani did not commit, but will not enforce crimes that people did do and who confessed to doing so NOT at the insistence of the prosecutors or court. Judge Ezra did tamper with or allowed the Hawaii federal grand juries to be tampered with in order to make sure that ONLY the prosecutors or court can author felony confessions and evidence proving same. Even drug dealers will now be able to escape punishment merely by voluntarily confessing prior to being prompted to do so.

Exhibit "2" is a true and accurate copy of the related October 26, 1998 letter from the Kingdom of Hawaii to the Bishop Estate Trustees, received by the Office of the Governor the next day. This document describes felony crimes ongoing against Hawaiians since the United States, as an ally of the Kingdom of Hawaii, invaded and attempted to conquer its own ally.

Lokelani was intimidated and coerced into accepting a plea bargain. Even then, the offered terms were much reduced in harshness from the original prosecution efforts because they were shown that the key corporate documents they relied upon had two different versions they were relying on. That demonstrated that Lokelani had been set up by forged documents. Also, even now Judge Ezra continues to show his bias against Lokelani by refusing to correct the record after wrongly saying that Lokelani committed bankruptcy fraud. The transcripts show that Judge Ezra spent his court time mainly ranting and raving about the Bishop Estate and its ills rather than focus on Lokelani. Even Lokelani's own sister testified that she could not remember if she informed Lokelani about any details of that bankruptcy.

Since my federal grand jury was tampered with (material prejudice), my indictment is void, and therefore Lokelani alternatively requests that this case be dismissed.

Exhibit "3" is a true and accurate copy of Lokelani's letter to the IRS Criminal

Investigation Division filed July 30, 2003.

Exhibit "4" is a true and accurate copy of Lokelani's amended 1040X for 2000.

There are a number of other valid reasons for granting these motions which will be forthcoming shortly. Mainly, Lokelani was railroaded because Lokelani began to whistleblow. Lokelani obviously is continuing to be a whistleblower because those whom Lokelani was whistleblowing against were so far unsuccessful in killing Lokelani.

Attached also is the original of Lokelani's July 30, 2003 Affidavit.

- The Kingdom of Hawai'i is taking Bishop Estate and their cohorts to the Federal Grand Juries on a RICO complaint type format.

Ano ai mei ke aloha ke Akua Trustees,

As Kanaka Maoli (Hawaiian), who as many individuals have an interest in the Trust as a beneficiary, etc. for the future of my born and unborn descendants in their inherent rights. I represent the Kingdom of Hawaii as the Minister of the Interior. A nation that is in restoration, and we are doing our best to put things in Ua mau ke ea o ka aina i ka pono.

We see the STATE OF HAWAII committing a conspiracy against the Trust. Handing it over to foreign individuals that will take over the Trust for the benefit of everyone else but our children of Hawaiian ancestry and the future of the Kingdom of Hawaii.

Princess Bernice Pauahi mentioned in her Document that the children shall become industrious men and women. We believe that she intended that her country will be an industrious country. After all the children are the future.

We know that our Princess was a Christian as she speaks of the Protestant religion. Her intentions was that all the teachers should be Christians teaching our children the ways of the LORD in His ways and not our ways.

The Constitution of the Kingdom of Hawaii acknowledges that the laws of the Kingdom of Hawaii shall be in accordance with God Almighty. The Kingdom of Hawaii is one of the risen

nations by God. As Christians that you are we should adhere to the LORD and do as the Will and Trust of the Princess Bernice Pauahi.

The Kingdom of Hawaii is in restoration by the grace of God. We only hope and pray that you will do what is right and repent for God's country is rising and we would like for you to be a part of it. I would like to propose to you the following actions we believe that needs to be done immediately and the reasons why I propose the following:

1. Removal of the non-profit status off the Trust.

Princess Bernice Pauahi's Trust is a private Trust. By obtaining a non-profit status it leaves the door wide open for the STATE OF HAWAII and the UNITED STATES OF AMERICA to investigate and try to manipulate the Trust to their advantage. The Trust does not need the non-profit status, it can hold its own. According to her Will, the Trust is in the jurisdiction of the Kingdom of Hawaii. She speaks of her country, which is the Kingdom of Hawaii.

We are well aware that the Trustees hold a lot of power with the Trust. However, as long as you the Trustees acknowledge the Trust being in the jurisdiction of the State of Hawaii, you will be continually harassed by the State of Hawaii's Attorney General and the State and/or Federal agencies directly or indirectly. To have a public appointment with the media of you into office as Trustees by the Kingdom of Hawaii judiciary officers or higher, will confirm and show the people that the Kingdom of Hawaii is here and alive, being restored and that you the Trustees are taking the proper actions according to the Will of the Princess in her Trust. You will be truly carrying out her Will literally. We believe this will save grace upon yourselves and the future of our children.

3. Complaint and removal of, but not limited to teachers, and individuals who partook in the conspiracy against the Trust.

As Trustees you do or should take an oath to the Trust, and I am sure that the teachers and others do or should take such an oath. Those individuals who partook in the conspiracy against the

Trust should be removed from their positions. In any case, pursuant to the continued patterns of wrongdoing comprising a substantially long ongoing enterprise to predicate acts against the Trust and its beneficiaries, direct and indirect, thousands of Hawaiian beneficiaries are expected to join in what would essentially be a class action Racketeer Influenced and Corrupt Organizations Act, 18 U.S.C. 

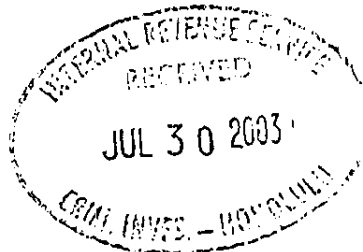

I just hope that the federal Grand Juries get my admission, and that no one in your Division or in the U.S. Attorney's office or in the Court, block this legitimate request.

I do not authorize the Examination Division to have any power or authority or jurisdiction over or related to these returns.

## AFFIDAVIT OF LOKELANI LINDSEY

I, LOKELANI LINDSEY, hereby declare and aver under oath the following:

I am concerned about people in authority attacking me and setting me up, more so than in the past; and especially for the life, health and safety of myself, my family, my friends, my associates, and my property and their property. I hold responsible Leslie Osborne, Michael Seabright, Thomas Stevens, and Rebecca McKenzie-Young, as the insurer of my and their life, health and safety. I do this because:

1. I have insider knowledge of Bishop Estate corruption and cover up of same.
2. I have insider knowledge of corrupt attempts to seize control over the Bishop Estate.
3. I have insider knowledge of further attempts to or acts of abuse of Hawaiians.
4. I have insider knowledge of grand jury tampering in Hawaii.
5. I have insider knowledge of other political and financial corruption in this state, and the targeting of people and groups related thereto.

On behalf of the Hawaii active Whistleblowers Association International, Inc., aka HAWAII, I am here to defend Hawaiians and do encourage all Hawaiians to bring their evidence of abuse and cover up to me so that I can bring that and the above to the Grand Juries here and/or elsewhere.

The HAWAII Foundation is diligently seeking anyone in Hawaii to better take the alleged crimes and cover-ups in Hawaii to the various Grand Juries for their determination as to probable cause for such matters. (See Fifth Amendment of the U.S. Constitution.)

The abuses against Hawaiians has been and is race based, (see Rice v. Cayetano) and thus civil genocide. These abuses are on a long, continuous conspiracy to steal the birthright and heritage, assets and rights of Hawaiians. The Internal Revenue Service, State of Hawaii and the Bishop Estate are mere Guardians for their Wards, the Hawaiians. The Guardianship must be broken and the Hawaiians freed from assaults similar to those perpetrated by Nazi Germany as revealed in the post World War II Nuremberg trials. The Trust was never broken, especially NOT by me. The Guardianship over the Hawaiian Wards continues, except that now the current Trustees and quasi-trustees (Internal Revenue Service and Hawaii Attorney General) have greatly enhanced the effective stripping of assets and rights from the Hawaiians. I was a Guardian and now I am merely a Hawaiian Ward of these abusive overlords who perpetuate the race based subjugation of the Hawaiians.

Bernice Pauahi Bishop intended for the trust she established to be governed for the purpose of preserving the Hawaiians their assets and heritage in perpetuity. However, the felonies which have been and are being committed in the wholesale attacks on the Bishop Estate are for another goal. The true goal of the current overlords is to put the Bishop

Estate and other Hawaiian (such as OHA) assets into the General Fund of the State of Hawaii (and related destinations), and also let the State of Hawaii and the United States just keep the assets of the Hawaiians in trust under their jurisdiction.

If I go to prison, I will have an opportunity for many prisoners to join the Foundation and me in our march to the Grand Juries here and into many states.

I was arrested to block me from taking to the Grand Jury the evidence that I and others have of serious abuses in the Bishop Estate, abuses against the Hawaiians, and especially against the Hawaiian children. Among others we are especially looking for additional alleged indicting evidence against those which include Jack Borja, Rebecca McKenzie-Young, Leslie Osborne, Mike Chun, Oswald Stender, Randy Roth, Judge David Ezra (and his being counsel for Bank of Hawaii), and Ed Case, who all have alleged long histories of such abuses. The Grand Juries are the only appropriate Court to review these and related matters.

Although claimed by such parties to be a minor matter, the recent Bishop Estate loss of about \$2 billion and sale of assets to cover up the losses, will also be reviewed by Grand Juries. The matter of thefts from the Kamehameha Schools and Heritage Center of artifacts and other precious items will also be reviewed.

I have evidence and am seeking more regarding the Grand Juries in Hawaii and number of ways abused. I am a victim of such abuse. I confess to any crimes which the United States has not or will not otherwise prosecute.

I have been threatened with harm to myself, my family and friends, our lives, health and property, and am very worried these threats will be further carried out, including potentially by one or more of those people named above, directly or through others. A copy of this is being sent to my Las Vegas attorney, Judge David Ezra, the two prosecutors named above, and as appropriate.


