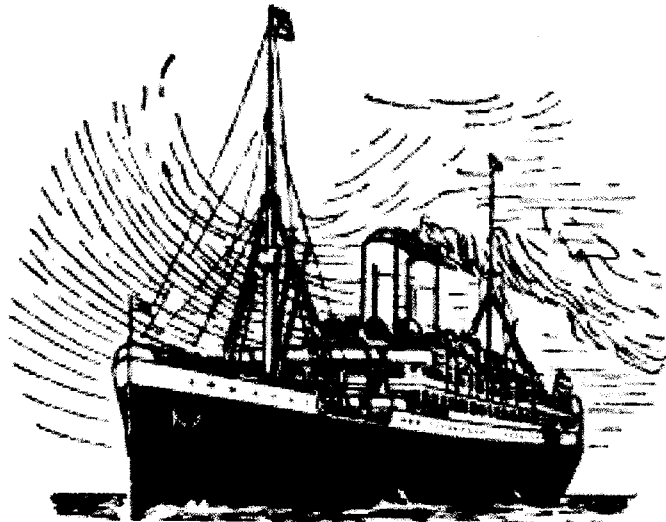
## Joint Meeting

The July meeting will be a joint luncheon meeting with the Independent Insurance Agents of Long Beach on the Queen Mary.

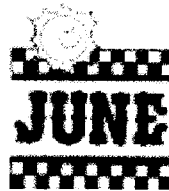
The luncheon will be in the Chelsea Restaurant on the Promenade Deck of the Queen and begins at 12:00 p.m.
