## **Explanation of Preliminary Property Tax Estimate for Saint Paul properties.**

This web site calculates a parcel-specific preliminary estimate of proposed 2004 property taxes for property owners in the City of Saint Paul. You will receive an official, more accurate estimate from Ramsey County in November.

The above estimates are based on maximum tax levies certified in September by the three major taxing jurisdictions: Ramsey County, the City of Saint Paul, and the Saint Paul School district, as well as estimates of the levies of the six other smaller units of government that collect property taxes in the City of Saint Paul. The estimate also includes the 2003 voter-approved levy referendum for the Saint Paul School District.

Please note the following caveats about these estimates:

- The estimates do not include county and city assessments and service charges.
- The estimates assume the accuracy and stability of property value records. Sometimes values are adjusted by Ramsey County after initial values are set, which would change the above estimates.
- The tax rates used to calculate this preliminary estimate may differ from the rates used to calculate the official estimate from Ramsey County (to be mailed in November) and from the final rates which will be approved by all the taxing jurisdictions in December after the Truth-In-Taxation Public Hearing on December 9th at 6:00 p.m., Arlington High School, 1495 Rice Street. Therefore, this estimate will be different than the Ramsey County estimate in November and the actual final tax bill which will be mailed in February 2004. Nevertheless, we believe that this estimate will be very close to both the Ramsey County estimate and the final tax bill and it is therefore useful information for all taxpayers.
