6-21-91	Visited Danish Embassy, presented letter.	Man said no-one was available to interview me on such short notice. He accepted my letter and some documentation, promised they would receive attention.
7-22-91	Letter to Rodino and Rodino, Attorneys, seeking limited representation as I leave country.	No response received.
