4.a. Fuelwood harvesting. Darrin Sinclair and Robin Sharples of Yukon Government Forestry were present to discuss personal fuelwood harvest. A free permit for up to 10 cords of wood can be obtained from the department. There are permit maps on-line along with guidelines for spacing and height of stumps. There are designated and non-designated areas, the latter of which can be discussed with Forestry to obtain a permit. There are areas of standing dead from the recent floods, and these areas can be applied for by non-designated permit.

Council thanked Sinclair and Sharples for attending the meeting.

- **4.b. Southern Lakes Water Committee.** Dale Stokes reported on the Water Board hearings about the Yukon Energy Corporation's 20-year application for the Whitehorse dam that occurred in July. The Water Committee found they had no YG representation. Fish protection and Indigenous perspectives, along with flood protection will need to be addressed.
- **4.c. MLA John Streicker, Southern Lakes.** This is Streicker's last meeting as MLA. He will not be running in the 2025 territorial election. Streicker will offer all data links to water levels to the next MLA, and any issues outstanding in the electoral district.
