4. Guest Speakers and Public Discussions.

4.a. James Paterson, Director and Fire Marshall for Protective Services, Yukon Government spoke briefly on a request from residents to relocate the fire hall in Judas Creek to a more central position in the overall community. Issues that will have to be looked at before any changes can be made are whether a satilite station in Army Beach can be created, population density and where the majority of the emergency call outs are coming from. It is found medical emergencies are spread out through the community but highway

The issue of dispatchers not knowing the roads in Marsh Lake was mentioned. Lack of maps and local knowledge are an ongoing problem. There are plans to address this by 2020.

Paterson also spoke on Wildland Fire Management. Although residents of Marsh Lake did an emergency plan back in 2012 it is now outdated and new instructions need to be available to residents in case of evacuation.

The draft Forest Management Plan is almost ready for public input.

Water access to the community centre was brought up at the recent LAC Forum. An answer might not be simple since it would mean creating a distribution centre so an assessment will be done and a solution found.

The contractor for the Marsh Lake transfer station has been found although the contract does not mention the operation of a refundables depot.
