1. Call To Order.

5. Report from the Chair & Correspondence.

- received an email from MLA Streicker stating plans for a possible cell tower booster for Judas Creek has been put on hold indefinitely.
- Chair Jo-Anne Smith has been following up on the status of the Marsh Lake Land Use Plan and will be next contacting Yukon Government for an update.

Report on LAC Forum: all Councillors were in attendance.

-Received an email discussing the controversy of mineral staking in rural communities. Council will follow the developments happening in the community of Mount Lorne.

4. Guest Speakers and Public Discussions.

4. a. Waterfront Properties in Southern Lakes: An issue over the legal OHW setback marked on property owners' land deeds has recently been in the news. The issue seems to have been resolved, but anyone with concerns should contact their MLA.

4.b. Army Beach Lake Access Trails: The August meeting with residents of Army Beach discussed a number of issues to be addressed. Which paths should be reopened, should there be signage or fencing, who will maintain the paths once open plus other concerns. The committee will work with the YG Community Advisor to send out a letter to all residents along Army Beach and the issue should be on the February Council agenda.

6.c. Marsh Lake Emergency Services Society: MLA Streicker wrote a reply to residents' request to have the Fire Hall moved. There will be an analysis done on getting equipment and relocating. However,

the volunteer base must be in place for such a plan to follow through. An analysis will also be made of the potential of a satellite Fire Hall in Army Beach. Community Services will respond once complete.

6.d. Marsh Lake Solid Waste Facility: Tipping fees are still being discussed. Free store is still a mess as users are unwilling to clean up after themselves.

There has been a complaint about the overflowing garbage bin located at the M'Clintock Place boat launch. It's unclear who is using it or if anyone has the responsibility of emptying it in the winter months.

7. Old Business.

Judas Creek Civic Addressing: Councillor Blair Corley has been following up with the utility companies, the EMS and Fire Marshall's office, and Elections Canada and none of them have the new civic addressing for Judas Creek. Council requests Community Services follow through with the new addresses with these organizations.

8. New Business and Question Period.

Wildfire Hazards: Blair Corley took Emergency Response Officer Doug Cote from Wildfire Management through Judas Creek and New Constabulary to look at downed trees from the November snow storm. The department is willing to look at new FireSmart funding to clean up the areas and encourages all residents to keep their properties clear of debris.
